And this, rational government will not do. They still remain Imo. State Government's properties, with the right selection and planning, the concession can greatly enhance the profitability of an overall operation. While an area touched by concession policies may not necessarily be the state's primary source of revenue, it must be approached with the goal of increasing bottom-line profit for the state.

ear of harm and what is to come in the future which is seldom predictable is one of the many things that hinder most of Christ's followers into following faithfully the direction, precepts, and exemplary life of the master – Jesus Christ, Significant numbers of Christans-no-longer-live as expected of them due to fear of being assaulted, insulted or even killed by the fanalics of Christianity; heretics and the violent members of other religious sects. Often times we (Christians) are so much intimidated that we can't speak for Christ our leader, guide and epitome of our faith. (Jn. 713, 1242-43). As a result of falling into this so cial and religious intimidation, our goal of evangelization of Christ's message of salvation is hindered and Left unaccomplished.

Jesus said "... do not be afraid of those who kill the body but cannot afterwards do anything worse ... fear God, who, after killing, has the authority to throw into hell. Believe me, he is the one you must fear!" (Lk. 12'4-5). When we believe and trust in the Lord, fear evaporates from us (cf. 1Sam 14:6). A Christian with unshakeable faith in God and his promises is not afraid of trials and troubles (Acts 5:17-18), because the spirt of God who inspires us to have-faith in Him, and who guides our hearts and minds into serving him faithfully fills us with power and does not make us timid (2Tim 1.7).

It is obvious that Jesus conceived that to "follow him truly" is not an easy task; it is not a place of comfort. Christianity is not a bed of roses. In my view, justice would have been better served with eyes wide open. But I am told that being blindfolded means that Justice is fair and acts without fear and favour.

In Imo State like elsewhere in the world, Justice is also blind, blind to the suffering and anguish of litigants pauperized by extensive judicial processes, poorly motivated judicial staff who are always owed backlogs of pays and often striking while awaiting trial mates languish in prisons because of onerous bail conditions. Records of Corruption in the Imo State judiciary however are perhaps lowest in the eastern region but there are seemly no existing and effective policies to monitor and check same as they are not unremarkable and inconsequential.
